Contact Group 2 - Article 8

This is a proposal for streamlining for consideration on paragraphs 1, 3 and 4 from Article 8 by the co-facilitators of the informal group from Chile & Switzerland as of Monday, 11th of August 2025, 12pm

Paragraph 1: Text with track-changes

1.
